Underprivileged children growing up in the slums experience a childhood that often defies the imagination of both the innocent childhood proponents and the universal childhood advocates. These slums where children live lack proper sanitation, safe drinking water, proper garbage collection, and have mosquitoes breeding in the dirty water along with shortage of space inside the houses. These children have a different childhood playing on a rough, uneven ground taking on multiple roles in everyday life and sharing responsibilities with adults in domestic and public spaces in the community. These children see abuse of their mother's every day. The men beat their wives after consuming alcohol. Slum children in India face additional vulnerability because of their lack of access to nutritious food, sanitation and medical care. Their life is filled with darkness and hopelessness. They live a very miserable life, which is full of woes, diseases, poverty and uncertainty. Lack of education facilities mean that some children (more than 80% of under 18's) do not go to school and are forced into child labour. Children born in slums often do not have birth certificates and without this they cannot access healthcare, education or exert their human rights. Most slum houses do not even have individual toilets and taps. The community has to pay for using the community toilets which are rarely maintained. The drinking water is also overpriced. Children suffer from high rates of diarrhea and respiratory illness, malnutrition and have low vaccination rates.

# MISSION EDUCATION Every child has the right to learn.



### 'Education is a battle against poverty that everyone should fight.'

Education is a process of teaching, training and learning, especially in schools, colleges or universities to improve knowledge and develop skills.Education develops critical thinking. This is vital in teaching a person how to use logic when making decisions and interacting with people (for example boosting creativity, enhancing time management). Education helps an individual meet basic job qualifications and makes them more likely to secure better jobs.

Education refers to the discipline that is concerned with methods of teaching and learning in schools or school-like environments as opposed to various non-formal and informal means of socialization. Education is the key to liberating children from slavery. Education is not preparation for life, education is life itself. The purpose of education is to replace an empty mind with an open one. Education is learning what you did not even know you did not know. Education is the only way through which one can make their future bright and oneself self-capable and self-sufficient. With this positive view Abhilasha Foundation organizes awareness programmes on the need and benefits of education. We have set up 16 portable classroom. They are not only provided with quality education but also with quality stationary, life skills and focus on teaching English to them.

#### **OUR EDUCATIONAL CENTRES AT VARIOUS LOCATIONS ARE AS FOLLOWS:**

- 1. The Maharashtra Education Welfare Trust, Kandivali: Installed two digital classrooms for the underprivileged children. More than 325 underprivileged children are catering education and provided holistic development.
- 2. Matoshree Vidya Mandir, Mankhurd: Installed 4 digital classrooms for more than 3102 underprivileged children are catering education and provided holistic development.
- 3. National Educational Social Trust: Installed double decker classrooms for more than 2910 children are catering education and provided holistic development
- 4. Zilla Parishad School, Saiwan Village, Vasai: Installed 1 classroom for more than 1082 tribal and underprivileged children are catering education.
- 5. Ambuj Wadi, Malad: Installed 1 portable classroom and more than 350 students are catering education.
- 6. Shree Dhyaneshwar Vidya Madir, Netaji Nagar, Bandar Pakhadi Road, Kandivali West; installed digital classroom for 625 children are catering education.
- 7. Saraswati Vidyalay, Petkar Compound, Damu Nagar, Akurli Road, Kandivali East: Installed Digital classroom for 435 children who are catering education.

# **RELIEF TO POVERTY:**



Poverty entails more than lack of income and productive resources to ensure sustainable livelihoods. Its manifestations include hunger and malnutrition. Eliminating poverty through equity. One of the main causes of poverty is inequality. Eradicating poverty through education. If people are educated, then poverty will be eradicated automatically. Hence, education is the most important key for the progress of the country. End hunger, achieve food, security and improved nutrition and promote sustainable agriculture. Ensure healthy living and promote well-being for all at all ages. One of the main causes of inequality is poverty. The systemic barriers that lead to groups of people going without representation in their communities leaves them further behind in terms of resources and opportunity. Reducing poverty with resilience. Poverty happens when a high amount of inequality meets a high amount of risk. If all students in the low-income group had just the basic reading and writing skills many people can escape extreme poverty. Education develops skills and abilities, corrects the imbalances that come out of marginalization and decreases both risk and vulnerability. Making sure that education is truly for all involve breaking down the barriers to education, creating access to school in remote areas, supporting the teachers in their work and training them to deliver quality education and making sure that education is available to children living in fragile contexts. Halting poverty by ending hunger: simply eating 3 meals a day and getting a healthy amount of calories and nutrients can break the cycle of poverty. When a person does not have enough to eat, they lack the strength and energy needed to work.

Good nutrition is the bedrock of child survival and development.



## MISSION HEALTH CARE



India has a multi-payer universal health care model that is paid for by a combination of public and private health insurance funds along with the element of almost entirely tax-funded public hospitals. A health system is an organization of people, institutions, and resources that delivers health care services to meet the health needs of target populations. Global health systems focus on issues such as governance, healthcare financing, and human resources for health. Fundamentally, global health is about achieving better health outcomes for vulnerable populations and communities around the world. We work with various hospitals such as Kamalnayan Bajaj Hospital-Aurangabad, Jupiter Hospital-Pune, Ashokamedicare Hospital-Nashik, Onco Life Cancer Center, Satara, Asian Heart Institute & Research Centre Pvt. Ltd., Sir H N Reliance Foundation Hospital and Research Centre, Jupiter Lifeline Hospitals Ltd. P D Hinduja National Hospital & Medical Research Center, Bai Jerbai Wadia Hospital for Children etc.

Impact: More than 315 critical medical surgeries and cancer chemo treatments were carried out for underprivileged children suffering from deathly heart ailments and other diseases.

Health awareness: Poor slum dweller's health awareness is largely affected by a lack of education and information that stops them from going to trained doctors and better services. Further, they are doubly affected because of poor living conditions with inadequate preventive health facilities and lack of sufficient curative healthcare. The slum dwellers need to be educated about health and diseases through awareness programs. They need to know what to eat, what not to eat, and how to be fit through regular exercise, proper diet, and health. Everyone must be aware of the required annual screening tests they need to undergo, based on their age, gender, and health conditions. There are several children and adults with serious medical conditions. They are looking for financial help to undergo critical surgery or treatment. If treated on time, they can live for many more years. In many cases, if one person is cured it saves the entire family.

Awareness for sanitation, dental, eye camps, and usage of sanitary pads is held frequently in the slum community.

Abhilasha Foundation is working hard to support the following initiatives:

Conduct eye camps to screen any ailments, awareness programs about diabetes, heart ailments, cholesterol, fitness, yoga, and meditation for the community.

Sponsor medical treatment for underprivileged children for their critical medical surgeries.






